Liability Waiver - The Castle of Eternal Suffering

Booking Holder Responsibility

The person making the reservation agrees to inform all participants that they are each required to complete their own liability waiver form before the start of the game. No one will be allowed to participate without having completed this form.

By making a reservation, the booking holder also confirms that all members of their group have been informed of the rules, understand the safety requirements, and meet the participation criteria.

⚠ Anyone who has not signed their waiver will not be allowed to participate. No refunds will be issued, even if certain rules were not verbally repeated.

⚠ The maximum number of players is **6 people**. If a group arrives with 7 or more participants, **any** additional person will not be allowed to participate. This limit is non-negotiable and is due to physical and technical constraints of the scenario. No refunds or compensation will be issued.

1. Introduction

The Castle of Eternal Suffering is an immersive experience featuring special effects and physical challenges. By signing, the participant acknowledges having received all necessary information, understood the rules, and agreed to participate knowingly and at their own risk.

While **Sauve Qui Peut** implements strict safety measures, the company disclaims all liability for injury, accident, or material damage, except in cases of gross negligence.

2. Game-Related Risks

The participant acknowledges and accepts the following risks:

- **Physical activity:** climbing, crawling, stepping up, entering tight spaces, and temporary isolation. Risk of minor injuries (scratches, bruises, etc.).
- **Special effects:** flashing lights, total darkness, loud sounds, artificial smoke, and other sensory stimuli that may cause stress or discomfort.
- Confined spaces: some narrow passages may trigger anxiety or claustrophobia.
- Personal belongings: all pockets must be emptied before entering. Lost items may be unrecoverable. Sauve Qui Peut assumes no responsibility for lost, stolen, or damaged property.

Emergency Button Use

- To be used **only in case of real danger**.
- Any unjustified or accidental activation will end the game without refund.

Personal Belongings and External Equipment

- Pockets must be completely emptied before entry.
- No external objects allowed (flashlights, tools, phones, etc.).
- Electronic devices such as phones, smartwatches, or any other device that can create artificial light are prohibited
- In case of rule violations, Sauve Qui Peut is not liable for any resulting injuries, losses, or damages.

Serious or repeated violations may result in the **game being terminated for the entire group** without refund.

6. Acknowledgment and Waiver

By signing this waiver:

- The participant confirms having read, understood, and accepted all rules.
- They understand that **no refund will be granted** in the event of rule violations.
